Open Letter to the Secretary-General of the United Nations for immediate action on Turkey

Re: Turkish invasion of the Kurdish canton of Afrin in Syria

Dear Secretary-General,

The armed forces of the Republic of Turkey are engaged in an illegal invasion of the Syrian Kurdish region of Afrin – violating the borders of a neighbouring country and pursuing a military strategy based upon war crimes.

While Turkey claims to have launched the operation to protect its borders and combat a so-called "enemy", the enemy per the Turkish state's narrative are none less than the internationally respected fighters of the Kurdish People's Protection Units (YPG) and Women's Protection Units (YPJ), who have played a key role in defeating the jihadist militants of the Islamic State (ISIS) terrorist group in Syria. Despite Turkey's use of various pretexts, including that of border security, this military aggression aims only to enforce Ankara's geopolitical agenda on the region through unprovoked and deadly force.

While predominantly Kurdish, the canton of Afrin is home to many ethnic groups including Arabs, Assyrians, Arameans, Turkmens, Alawites, Yazidis, Armenians and Chechens – a reflection of the diversity of Syria as a whole. Throughout the years of brutal civil war in Syria, the canton of Afrin has remained an island of stability and security, and for this reason it has been able to provide refugee to almost 300,000 internally displaced Syrians of various ethnicities and religions from other parts of the country.

No attacks have been launched on Turkey from Afrin or any other of the predominantly Kurdish cantons in northern Syria – the only military exchanges that have occurred have been in response to provocation from the Turkish military or jihadist armed groups backed by Turkey, both of whom have repeatedly launched attacks on Afrin and the other cantons of northern Syria from across the Turkish border.

Dear Secretary-General,

Since the outbreak of the Syrian conflict, Turkey has supported numerous jihadist groups in Syria, including ISIS and al-Qaida. Turkey used these groups as proxy instruments to target the indigenous Kurdish people of Syria. Turkey organised ISIS' attack against Kobani in 2014, and nonetheless it was in Kobani in March 2015 that ISIS, which was expanding throughout Syria and Iraq at an alarming pace, was dealt its first defeat through the resistance of the YPG and YPJ. The Kurds of Syria and their partners proved themselves to be the most dependable and effective local forces in the battle against the terrorist organisation, becoming a vital element of the International Coalition Against ISIS. Two and a half years after the Kurds' victory in Kobani, the Syrian Democratic Forces (SDF, of which the YPG and YPJ are a major force), liberated Raqqa, formerly the de facto capital and terror planning centre of ISIS – used by the group to coordinate attacks throughout the region and the world. At present, the most secure, stable and democratic regions of Syria are those administered by the Kurds and their partners.

The liberation of Raqqa was a landmark in the battle against ISIS, and the terrorist organisation that once controlled large swathes of land throughout Syria and Iraq is now isolated to small, collapsing, disjointed pockets of territory. We are gravely concerned that Turkey's current military operation targeting the opponents of ISIS may give new life to ISIS, which has been pushed to the brink of defeat in northern Syria. We do not want to see ISIS return to northern Syria and spread once again. ISIS has demonstrated that it is not merely a threat to Iraq and Syria, but also a global threat.

The UNSC convened on 22 January 2018, but dit not even manage to condemn the Turkish offensive. This stance ensures that the UN is a mere bystander in the face of this unprovoked aggression.

We urge you to take the following immediate actions:

- Take a clear stance against the Turkish state's attacks
- Hold Turkey accountable for actions of their armed forces against civilians
- Designate Turkey's cross-border operation an illegal act of invasion, an abuse of the UN Charter and violation of international law
- On the occasion of the 4th anniversary of the proclamation of Canton Afrin on January 29, we call the UN to recognise the democratic self-government of Northern Syria's people.
